- ❖ In case of car theft / car sold, immediately report to DHA Security at Phone 051-5789268 / 03239718307 followed by copy of FIR in case of theft.
- ❖ In case of vehicle sold / Accidented E-Tag must be returned to E-Tag Office, otherwise vehicle will continue to be treated on the name of applicant.
- ❖ To get duplicate E-Tag in case of damage or because of any reason an amount of Rs 600 will be charged.
- ❖ Validity period of E-Tag would be one year from the date of installation.
- ❖ The above mentioned charges will be deposited in DHA Acct **1061650500040** of Askari Bank
- ❖ The individual failing in returning expired / damaged tag would not be issued a new tag.
- ❖ DHA shall not be responsible for any damage caused to the vehicle due to barrier hit. Therefore, maintain a distance of at least 10 meters from vehicle in front, while crossing the barrier.

- ❖ The vehicle must be registered in the name of applicant.
- ❖ No cargo vehicles will be issued with E-Tag.
